Registration becomes permanent upon the third renewal and kennel names may be transferred only with written permission from the registered owner. In order for your kennel name to be used in the naming of a dog, it MUST be registered with MASCA, otherwise the breeder's surname will be substituted. Please read the Kennel Name Regulations on the reverse of this Application.

Kennel Name Regulations

- Rule 1. Kennel Names must be renewed after five (5) years, ten (10) years and fifteen (15) years from initial date of the Application for Kennel Name, as which point the Kennel Name becomes permanently assigned.
- Rule 2. All owners of said Kennel Name must sign the Application for Kennel Name. Once the Kennel Name is accepted and registered with MASCA, no other breeder or owner will be permitted to use said Kennel Name without written permission of the recorded owner(s) of the Kennel Name, unless the Kennel Name registration is permitted to expire before becoming permanently assigned. (See: Rule 1)
- Rule 3. Once the Kennel Name is permanently assigned by MASCA, it belongs to that Kennel Name owner permanently unless the Kennel Name owner transfers it to someone else. If abandoned, it can never be adopted by someone else.
- Rule 4. Dogs' names are limited to 30 letters per name INCLUDING Kennel Name.
- Rule 5. Register only the Kennel Name to be used when naming the dog, i.e., Quality Aussie Kennel - all three names would have to be used in the name when registering the dog. It is therefore suggested that the words Australian Shepherd, Aussies, Kennels, Farms, etc. be deleted from your Application for Kennel Name. Kennel Name must be used as a prefix or suffix.
- Rule 6. A Kennel Name will only be recognized if it is registered with MASCA.
- Rule 7. A fee will be required to make any deletions, additions or transfers in ownership of a Kennel Name registration.
- Rule 8. An Application for Kennel Name and fee must be submitted to the Registrar whenever an initial registration, renewal or transfer in ownership is required.
- Rule 9. To transfer a Kennel Name, an Application for Kennel Name must be completed by the New Owner, and signed by BOTH the New Owner and former Owner(s) of the Kennel Name.
- Rule 10. NO ASCA / AKC / NSDR / NASCUSA KENNEL NAME MAY BE USED UNLESS APPLICANT IS THE REGISTERED OWNER OF THAT NAME. COPIES OF SUCH REGISTRATIONS ARE REQUIRED IN ORDER TO APPLY FOR SAID KENNEL NAME WITH MASCA.
- Rule 11. It is requested that applicants refrain from using surnames or colors as Kennel Names.

MASCA Kennel Name Agreement

Before a kennel name applicant may register a kennel name with MASCA, the applicant must first contact the Australian Shepherd Club of America (ASCA) in order to determine if the desired kennel name is already registered with ASCA. The applicant may contact ASCA by phone at (979) 778-1082 and is advised to become a member of ASCA in order protect his or her interests as an enthusiast of Australian Shepherds and as a kennel name applicant.

- If the applicant determines that the kennel name that he/she has selected to register with MASCA has already been registered with ASCA, that kennel name shall not be registered with MASCA.
- If in checking with ASCA, the applicant determines that the desired kennel name has not been taken, they shall sign this statement and return this form to MASCA.



I have determined by contacting ASCA that the kennel name _____ that I want to register with MASCA is not presently registered with ASCA.

I have been advised that joining ASCA and registering the desired kennel name with ASCA is the only way to ensure that no other member of ASCA will select and register the desired kennel name with ASCA. I realize that I must be a member in good standing with ASCA for two (2) consecutive years before ASCA will permit me to register a kennel name.
